Please read the following agreement carefully and submit the signed completed form along with your fees to: Wright City Strassenbash 2016, P.O. Box 444, Wright City, MO 63390

Booth Registration is not complete and will not be recorded until payment is received.

The Strassenbash Committee will do its best to accommodate all requests. However, in order to minimize duplications, the Strassenbash committee reserves the right to change booth sales items. We will do our best not to duplicate food items. Items will be reserved on a first reserved basis. Any changes will be discussed with the organization prior to Strassenbash. The event sponsor also reserves the right to refuse any organization or the sale of items deemed inappropriate for the festival.

No Booth will be allowed to block the view of another booth with canvas sides or back drops. Those booths needing sides and full backs will be placed on the perimeter of the booth area. Participants must provide their own tables, trash cans, extension cords, booth lights, chairs and any specific special needs. Vendors cooking food with an open flame must possess a fire extinguisher in the booth. The Chamber will also have a limited amount of change, so it is recommended that each booth have plenty of change for your cash boxes. **The Warren county Health Dept. requires any retail food (grocery, convenience store) or food service(restaurants, caters, taverns) establishments to have a 2017 FOOD ESTABLISHMENT MOBILE PERMIT. This permit is available through the Warren County Health Dept. at a cost of \$50.00.**

For the safety of everyone, no vehicles of any kind, will be allowed inside the park during the festival hours of Friday (9/15/17) 4:00 p.m. – 11:00 p.m. and Saturday (9/16/17) 10:00 a.m. to 11:00 p.m. **All parking spaces at Diekroeger Park are handicap or emergency services parking only.** Vendors must park outside the park.

ABSOLUTELY NO REAL OR ARTIFICIAL KNIVES, GUNS, OR ANY TYPE OF WEAPONS, SILLY STRING, PARTY POPPERS, FIREWORKS, CONFETTI, TOBACCO (REAL OR SIMULATED), SHAVING CREAM, HAIR PAINT OR OTHER ITEMS DEEMED INAPPROPRIATE WILL BE ALLOWED. THE WRIGHT CITY AREA CHAMBER OF COMMERCE RESERVES THE RIGHT TO STOP SALES OF ANY VENDOR FOR SELLING INAPPROPRIATE ITEMS.

The State of Missouri requires all vendors who are not non-profit to collect sales tax.
