Vendor Agrees To The Following By Signing the Application:

All items are made by Vendor

1. Vendor shall indemnify and hold harmless Wright City Area Chamber of Commerce from any and against all liability, claims, demands, damages, expenses fees, fines, penalties, suits, proceedings, actions and costs of actions, including attorney's fees for trial and on appeal, of any kind arising out of or in any way connected with this Vendor's use of the space(s), sale of goods or conduct of business by Vendor, its agents, servants, employees, customers, patrons or invitees or any act or omission of Vendor, its agents, servants, employees, customers, patrons or invitees.
2. Vendor is solely responsible for all monies collected from the sale of Vendor's goods plus collecting and reporting the sales tax. Wright City Area Chamber of Commerce is in no way responsible for any lost or stolen monies or items.
3. Vendor assumes all costs arising from the use of patented, trademarked or copyrighted materials, equipment, devised, processes, or dramatic rights used on or incorporated in the conduct of any Vendor at or related to its operations at the Strassenbash Craft Show; and Vendor agrees to indemnify and hold harmless from all damages, costs and expenses in law or equity for or on account of any patented, trademarked or copyrighted materials, equipment, devices, processes, or dramatic rights furnished or used by Vendor in connection with this agreement and will defend Wright City Area Chamber of Commerce regardless of whether it be groundless or fraudulent.
4. Vendor agrees NOT to leave trash behind. You must take everything with you when you leave.
5. Vendor understands there are NO REFUNDS or SHOW CREDITS for any reason once contract has been received and processed. Strassenbash Craft Show is a **rain or shine event**.
7. Vendor agrees to ensure all products, signs, banners do not interfere with the flow of traffic or limit another vendor's ability to function from their space. All products, marketing material, signs, banners and staff must remain in the vendor's assigned space.
8. Vendor placement assignments shall be at the sole discretion of Strassenbash committee. Vendor set up instructions will be forwarded to the email listed on this form approximately one week prior to the event.
9. Wright City Area Chamber of Commerce reserves the right to exclude and/or remove any product deemed unfit for the family atmosphere during this event.
10. Each Vendor is asked to stay in their spaces for duration of the event. If a vendor should leave early they will not be invited to return.
11. Wright City Area Chamber of Commerce reserves the right to remove any person involved in any behavior that is deemed unfit or inappropriate including, but not limited to verbal altercations or fighting of any kind.
